I. Consent Agenda Motion Carried

II. FY 2020 and FY 2021 Aging Schools Program Approved Projects Report

Informational Only

Funding Programs Manager Arabia Davis delivered a presentation on the current status of the FY 2020 and FY 2021 State General Obligation Bond Appropriations for the Aging Schools Program. For Fiscal Year 2020, the IAC received a total of 96 ASP applications from twenty-two jurisdictions of which 94 projects were approved, one (1) was canceled and one (1) was denied. To date a total of \$6,905,819 has been approved through the Fiscal Year 2020 ASP. For Fiscal Year 2021, the IAC received and staff approved a total of 27 ASP applications from eight jurisdictions. To date a total of \$1,384,128 has been approved through the Fiscal Year 2021 ASP. The contracted funds are required to be expended and reimbursed within six months following the end of the fiscal year in which the funds were allocated.

III. Maryland Public Schools: An Introduction to Fiscal Sustainability Revisions

Informational Only

Program Support Administrator Cassandra Viscarra presented a draft report which was originally presented to the Members on August 20, 2020, and which had since been revised based upon feedback received. The report is intended to provide a broad overview to the public of the importance of understanding the total cost of ownership of school facilities, and to explain the IAC's facility standards which include the Educational Facilities Sufficiency Standards and the Gross Area Baselines. Suggested revisions were tracked for the Member's review. There were no additional questions or revisions requested from the IAC Members. Ms. Viscarra noted that in the absence of additional feedback, the document would be finalized, published, and distributed to LEAs and other stakeholders.

IV. FY 2021 Capital Improvement Program Supplemental Information Report <u>Informational Only (Revised)</u>

School Facilities Branch Chief Fred Mason reported the findings of the FY21 Supplemental Information Survey to LEAs as a part of the CIP submission process. The IAC and partnering agencies surveyed four categories in which the IAC could differentiate among school systems for project reviews: air conditioning availability in classrooms; design and planning professionals on staff; open space instructional areas; and number of relocatable classrooms per LEA. A summary of the four categories and their findings was included in the IAC Agenda.

Upon request from the members, the "Student Enrollment over time per LEA" chart legend was shifted to the left following conclusion of the meeting. Furthermore, the "Age of Relocatables Classrooms in Use" was updated to accurately reflect Carroll County relocatable classroom ages following the conclusion of the meeting.



V. Baltimore City E15M HVAC Project Status Report

Motion Carried

Jamie Bridges, Baltimore City Program Manager, presented a motion to approve allocation adjustments for Baltimore City E15M HVAC projects at three(3) school facilities (#239 Benjamin Franklin BLDG, #87 Windsor Hills PK-8 and #84 Thomas Johnson PK-8). Upon a motion from Ms. Avara and a second from Mr. Lombardo, the motion passed unanimously.

VI. Baltimore City E15M HVAC Project Status Report

Informational Only

Jamie Bridges, Baltimore City Project Manager, presented a status report on the Baltimore City E15M HVAC allocation. Secretary Churchill requested that Mr. Bridges update the completion dates of each project on the chart at the next IAC Meeting.

Adjournment:

Before adjourning, Director Gorrell informed the members that on September 23rd, the Board of Public Works approved the Statewide Facilities Assessment contract. Director Gorrell noted that the project is underway and the contracted vendor has begun working on a pilot program. It is estimated that 50% of schools could be assessed by the end of March.

Dr. Salmon noted that she recently had an opportunity to visit Carroll County schools and elaborated on a major construction project at the Carroll County Career and Technology Center. Dr. Salmon was enthused that students were still able to attend classes in person while the construction project was ongoing.

The video-conference meeting of the Interagency Commission on School Construction adjourned at 9:30 a.m.

Item II. Prince George's County – Rescission of FY 2018 and FY 2019 Capital Improvements Program (CIP) Projects

Motion:

To approve:

- An accounting adjustment to show the reversion of \$533,000 for the Prince George's County Dwight D. Eisenhower Chilling/Cooling Tower Project as required by Education Article §5-303(j)(3);
- 2) the rescission of funding approval for the four (4) projects listed below totaling \$16,518,000 for Prince George's County Public Schools; and
- 3) the transfer of the FY 2018 CIP allocation of \$533,000 and FY 2019 CIP allocation of \$16,518,000 to the Statewide Reserved Appropriations Account for Prince George's County Public Schools.

Background Information:

Education Article §5-303(j)(3) states:

Any funds approved for a county for a project that has not been contracted for within 2 years of the approval of the project, shall be:

- 1. Available for another eligible project in the county in the current fiscal year; or
- 2. Reserved for eligible projects in the county in the next fiscal year, in addition to the new funds allocated for projects in the county in the next fiscal year, and may not supplant new funds allocated in the next fiscal year or in later fiscal years.

Consistent with this statute, IAC staff are recommending approval of an accounting adjustment to transfer \$533,000 for the Dwight D. Eisenhower Chilling/Cooling Tower project, which was allocated in 2017, to the fund reserved for Prince George's County.

Additionally, in a letter dated May 18, 2020, Prince George's County Public Schools (PGCPS) requested rescission of four (4) FY 2019 CIP systemic renovation projects, shown in the table below. These projects were approved by the Interagency Committee on School Construction in May 2019 and in accordance with Education Article 5-303(j)(3)(i). These projects were required to be contracted within 2 years of project approval. However, under the IAC's extension of CIP deadlines under the Governor's Executive Order dated March 12, 2020 entitled "Extending Certain Licenses, Permits, Registrations, and Other Governmental Authorizations, and Authorizing Suspension of Legal Time Requirements", Prince George's has requested rescission of these projects (see attached request letter). PGCPS indicates that they have been able to successfully execute some of the projects under related facility improvements or have found the subject facilities warrant modification to the original scale and budget significant enough to require a new funding plan.

On December 17, 2014, the Baltimore City Board of School Commissioners (BOC) approved the program closure of Langston Hughes Elementary School, effective August 30, 2015. On January 5, 2016 the BOC approved the disposition and transfer of the dedicated use of the school facility to the City of Baltimore because it was determined that the school was no longer needed for educational purposes. At that time the disposition of the building was undetermined. The current request from the city government is to approve the disposition as a sale to the Youth Educational Services, a 501 (c)(3) nonprofit organization for \$1.

On June 25, 2020 the City government has authorized the Mayor and City Council of Baltimore to sell, at either public or private sale, all its interest in the property known as 5001 Reisterstown Road aka Langston Hughes Elementary School (Block 4596, Lot 001) as it is no longer needed for public use. Reference Ordinance 20.379 and Council Bill 20-0534.

The current request from the city government is to approve the disposition as a sale to the Youth Educational Services, a 501 (c)(3) non profit organization for \$1, because of all the community programming that has been provided by the organization.

The bond debt has been settled by the city.

Item IV. Request for COMAR Waiver for Anne Arundel North County High HVAC/Fire Safety and Electrical TIMS Projects

Motion:

To approve the waiver of COMAR 14.39.02.14C(1) and COMAR 14.39.02.03D(2) as requested by Anne Arundel County Public Schools so that the FY 2022 Capital Improvement Program (CIP) request for Priority #2 North County High HVAC/Fire Safety and Priority #3 North County High TIMS projects will be eligible for State Funding.

Background Information:

COMAR 14.39.02.28 allows the IAC to waive or vary particular provisions of regulation to the extent that the waiver or variance is not inconsistent with State statutes if:

- A. In the IAC's determination, the application of a regulation in a specific case or in an emergency situation would be inequitable or contrary to the purposes of State law; and
- B. The office of the Attorney General approves the waiver for form and legal sufficiency.

COMAR 14.39.02.14C.(1) states:

An LEA may submit a request to the IAC to fund a systemic renovation project that has not been released for solicitation in its local capital improvement program.

COMAR 14.39.02.03D.(2) states:

A systemic renovation project solicited before IAC approval is ineligible for State funding".

In last year's CIP, Anne Arundel County requested priority #8, which was a request for approx. \$7.6 million (or ½ the cost) of a systemic HVAC and Fire Safety project at North County High and priority #9 at North County High for an electrical Technology in Maryland Schools (TIMS) project. The projects were reviewed and designated as "B" eligibility status, which is defined as "Deferred but eligible for local planning or construction funding" and further defined in the IAC's CIP (page 10) as "All IAC and LEA staff questions, problems, or comments have been resolved and the project is eligible for planning or funding, but it has been deferred due to fiscal constraints".

The County has included these projects in the FY 2022 CIP cycle, and this time for the full State share of approximately \$14 million for the HVAC project. However, because the project is already under construction, these projects would technically be ineligible. COMAR 14.39.02.14C(1) states that "An LEA may submit a request to the IAC to fund a systemic renovation project that has not been released for solicitation in its local capital improvement program" and COMAR 14.39.02.03D(2) states that "A systemic renovation project solicited before IAC approval is ineligible for State funding".

Anne Arundel interpreted the 'B' status in the FY 2021 CIP as confirmation that the project would be eligible for funding and therefore "approved". Historically, we have interpreted these sections of COMAR to mean that a systemic project that proceeded to bid without IAC approval of funding (regardless of a B status in a previous year) was ineligible for State funding.

Anne Arundel also demonstrated 2 instances where the IAC approved systemic projects that were underway before IAC approval.

- FY 19 CIP Priority # 12: Arundel Middle Roof project PSC# 02.057.19SR: The LEAs funding request showed a bid date of 5/18; however, the project bids were opened on April 2nd and April 5th. While it is highly unlikely that new and current IAC staff would have known about the bid opening at the time the project was recommended to the IAC for approval, the mistake should have been caught when the contract was submitted by the LEA. State funding for this project was expended on March 11, 2020.
- FY 19 Priority #17 Annapolis Middle HVAC/Windows/Sprinkler project PSC #02.061 was a "B": The LEA resubmitted the project in the FY 20 CIP and showed a bid date of 9/18.
 The project received IAC approval in May of 2019 and the contract award received approval in June of 2019. This clearly is a case where staff inadvertently did not perform their due diligence during the eligibility review and contract review phases.

Anne Arundel submitted the contract for these projects to the IAC as would be required for a State funded project. The contracts were circulated by staff internally and questions were raised because of the status of the projects as locally funded, but those concerns were not communicated back to Anne Arundel. Although Anne Arunded should have been aware of the COMAR provisions, the IAC also should have highlighted this concern to Anne Arundel when the contracts were submitted.

Because of the circumstances described in this agenda item and because award of a waiver would not be inconsistent with State statutes, IAC staff recommends that the IAC allow a waiver under COMAR 14.39.02.28 to allow the projects to become eligible in the FY 2022 CIP cycle.

Pragmatically, this issue has also provided us with an opportunity to review the logic of the COMAR requirements previously stated and believe that they may be contrary to completing projects that improve educational environments as quickly as possible. We will study this further, discuss with the LEAs, and may bring to you for consideration revisions to COMAR.

Anne Arundel County Public Schools (AACPS) is requesting a waiver of IAC Regulations that require a school construction systemic renovation project not be solicited for bidding prior to IAC approval, COMAR 23.03.02.D.(2). The systemic renovation projects we are asking waiver approval for are the North County High HVAC/Fire Safety and the North County High Electrical (TIMS).

In our FY2021 Capital Improvement Program (CIP) we requested funding for both the HVAC/Fire Safety, priority #7, and the Electrical (TIMS), priority #8. The necessity of the projects was based on our Comprehensive Maintenance Plan and receiving a poor review during an annual IAC inspection. Our local government had forward funded the design of the project, and a feasibility study was completed and submitted as part of our FY2021 request. The construction documents were submitted to the Department of General Services in December 2019. In May 2019 both projects received a "B" approval - Deferred, but eligible for local planning or construction funding from the IAC. With this approval, AACPS staff interpreted that the projects were eligible for construction funding and could move forward using local funds.

In our FY2022 CIP, the North County High HVAC/Fire Safety and the North County High Electrical (TIMS) projects are priority #2 and #3, respectively. The FY 2022 CIP funding request for construction is less than the FY2021 request and is the actual cost of the contracts and IAC form 303.3 that were submitted in June 2020.

With more focus on ventilation and air quality in schools due to COVID, it is crucial for this project to move forward. If a waiver is not approved this critical project will be suspended and other locally funded maintenance backlog projects will be deferred. The support of the IAC in granting this waiver will allow this project to maintain the current schedule, correct the deficiencies noted in the annual IAC inspection, and provide the students and staff an equitable and healthy learning environment.

To approve the use by the Washington County Board of Education (CCBOE) of 15 acres of land at 10435 Downsville Pike, Hagerstown, MD, 21740, for the construction of a new elementary school to replace two existing elementary schools; adhering to the actions identified in the state clearinghouse review, state identifier MD20200707-0581.

Background:

The Washington County Board of Education (WCBOE) requests site approval to enable it to use 15 acres of land at 10435 Downsville Pike, in Hagerstown, part of a 44.9-acre parcel owned by the Washington County Board of Education and occupied by WCBOE administrative offices, for the construction of an elementary school in Hagerstown. The school portion of the parcel is undeveloped and fronts on Downsville Pike.

In 2013, the Washington County Board of Education purchased the site, which included a 143,000-square foot building that now houses its administrative headquarters. It was the only site that WCBOE considered for the replacement school, given that it was owned by the Board of Education and has adequate acreage for a new elementary school.

Washington County's Educational Facilities Master Plan has identified the site for the development of a replacement elementary school to replace Hickory and Fountain Rock elementary schools, with a goal to open in 2024. The school will be designed to accommodate a state rated capacity of 785 students. It is currently designated in planning documents as Elementary School #1.

State Clearinghouse review was completed in August 2020. The Maryland Department of Transportation (MDOT) noted in its review that the location of this project on Downsville Pike (MD 636) may require an MDOT SHA (State Highway Administration) Access Permit, as Downsville Pike is a state roadway.

The WCBOE approved the site in 2013.

Land Use and Infrastructure

- The site is in the County's Priority Funding Area and is within the county-designated Hagerstown Growth Area.
- Current zoning is Office, Research and Industrial (ORI). Schools are allowed by right in this zoning district.
- The site is served by Downsville Pike, a state-maintained road. The school will require that a new vehicle entrance to the site be constructed, and acceleration and deceleration lanes be added to Downsville Pike.
- The site is served by public water and sewer.
- Natural gas is available at the site.
- Additional stormwater facilities will be needed when the site is developed for a school.

Environmental and Natural Settings

- The site is not within a 100-year floodplain.
- A wooded area, approximately 200 feet by 200 feet, will need to be cleared to provide vehicular access to the site.
- The site has swales along its northern and western borders that direct runoff to an offsite basin.
- The site is not considered prime agricultural land. The site is not designated for agricultural preservation or identified as a priority preservation area.
- No known rare, threatened or endangered species of plant or animals or habitats are known to exist on or near the site.

Item V.B. Site Acquisition and Approval – Montgomery County Public Schools – Gaithersburg Cluster Elementary School #8

Motion:

To approve the acquisition by the Montgomery County Board of Education (MCBOE) of 5.71 acres of land known as Kelley Park, at 400 Victory Farm Lane, Gaithersburg, Maryland, 20877, from the City of Gaithersburg, for the construction of and future use by Gaithersburg Cluster Elementary School #8; adhering to the actions identified in the state clearinghouse review, state identifier MD20200914-0782.

Background:

The Montgomery County Board of Education (MCBOE) requests approval from the Interagency Commission for School Construction (IAC) to acquire from the City of Gaithersburg 5.71 acres of land at 400 Victory Farm Lane in Gaithersburg, known as Kelley Park, to construct Gaithersburg Cluster Elementary School #8.

The Kelley Park site was the first choice among 10 potential sites that the Montgomery County Public Schools evaluated. The property is being dedicated by the City of Gaithersburg to the Board of Education at no cost per a Land Acquisition Agreement signed by both parties, dated June 2, 2020.

The school will be designed to accommodate a state rated capacity of 740 students in kindergarten through fifth grade, with the goal of addressing enrollment growth in the Gaithersburg area. Work on the project is expected to begin in January 2021, and the school is tentatively scheduled to open in Fall 2022.

Although the site is an existing park, the Board of Education intends to develop an agreement with the City of Gaithersburg for the shared use of a future turf field. The school playground will be available to the public during off-school hours.

The proposed school property, currently owned by the City of Gaithersburg, is being conveyed to the Montgomery County Public Schools in compliance with a resolution adopted by the City Council of Gaithersburg, dated April 20, 2020. After the state approval process is complete, the deed from the City of Gaithersburg will be recorded with Maryland Land Records.

State Clearinghouse review was completed in August 2020. The MCBOE approved the site on March 22, 2018.

Land Use and Infrastructure

- The site is in the County's Priority Funding Area.
- Current zoning is Low Density Residential (R-A) by the City of Gaithersburg. Schools are allowed by right in this zoning district.
- The site is in an established residential neighborhood with an existing suburban street network.
- Sidewalks exist along the site and vehicular access is provided via Victory Farm Drive.
- Washington Grove Volunteer Fire Department/MCFRS Station 8 is 2.1 miles from the site at 801 Russell Avenue, in Gaithersburg.

- The site is served by public water and sewer.
- Natural gas is available at the site.
- Stormwater management and sediment control measures will be coordinated with Montgomery County regulatory agencies during the permitting and construction phases.

Environmental and Natural Settings

- There is a 100-year flood plain adjacent to the property, but the school will not be built within it; the flood zone is predominately on undeveloped park property that is adjacent to the school site.
- Property is not heavily forested. A cluster of mature trees is located around the parking lot and baseball field.
- The site is not considered prime agricultural land. The site is not designated for agricultural preservation or identified as a priority preservation area.
- No known rare, threatened or endangered species of plant or animals or habitats are known to exist on or near the site.

Item V.C. Easement (More than One Acre) – Montgomery County Public Schools – John F Kennedy High School

Motion:

To approve the dedication of a forest conservation easement by the Montgomery County Board of Education (MCBOE) of 2.17 acres of land adjacent to John F Kennedy High School, 1901 Randolph Road, Wheaton, Maryland, 20902, to the Maryland-National Park and Planning Commission (M-NCPPC) to protect and prevent the alteration, construction or destruction of sensitive environmental forest buffers at the John F. Kennedy High School site, as required by M-NCPPC's development approval process and Montgomery County Code.

Background:

The Montgomery County Board of Education (MCBOE) requests approval from the Interagency Commission for School Construction (IAC) to dedicate a forest conservation easement of approximately 2.17 along Randolph Road, adjacent to John F. Kennedy High School, by the Montgomery County Board of Education (MCBOE) to the Maryland-National Park and Planning Commission (M-NCPPC).

One provision of M-NCPPC's development approval requires the execution of a Forest Conservation Easement for the addition project at John F. Kennedy High School, at 1901 Randolph Road, in Wheaton.

The proposed easement will not affect any land that could be used for school programming or recreational activities and will benefit both the school site and the community by preserving sensitive environmental areas.

The MCBOE approved the easement in May 2020.

Item V.D. Informational Property Change Item

Motion:

These items are informational and do not require IAC action.

The Montgomery County Board of Education is granting a forest conservation easement of 0.31 acres to the Maryland-National Capital Park and Planning Commission to support a facility upgrade project at Col. E. Brooke Lee Middle School, 11800 Monticello Avenue, Silver Spring, Maryland.

To approve the FY 2018 QZAB funding totaling \$220,000 for five (5) projects in Montgomery County as presented in this item.

Background Information:

The reauthorization of the QZAB program was not passed by the United States Congress; however, a total of \$220,000 in bond/interest remains available for immediate distribution with the caveat that the expenditure deadline of 12/15/2020 will need to be met. Therefore, an LEA seeking funding through this program must have a project that is ready to move forward expeditiously.

Montgomery County has identified the five projects shown in the table below that meet this criteria and by accepting funding through this program, the LEA agrees to comply with the internal revenue code. Review of the project has been completed and determined to meet the eligibility guidelines for the QZAB program.



Background Information:

Education Article, §5-304 Annotated Code of Maryland requires the IAC to approve a Capital Improvement Program (CIP) each year. This process typically begins around July 1 with the release of CIP instructions to the LEAs and concludes in May or June upon publication of the final State Capital Improvement Program.

Current CIP Process



The attached report shows preliminary project requests as submitted by the LEAs. Please note that these the requests presented at the December IAC meeting may differ slightly as the LEAs have until late November to submit revisions to their requests.

In summary, the IAC received 214 planning and funding requests for projects as shown in the table below.

The IAC is required to approve several iterations of the capital improvement program, to ensure the appropriate State flexibility while Maryalnd lawmakers conduct their work during each year's legislative session. Required approvals include:

- Approval of 75% of the preliminary school construction allocation on or before 12/31;
- Approval of 90% of the allocation included in the capital budget by 3/1; and
- Approval of 100% of the enacted capital budget bill by 5/1.

The IAC will issue preliminary staff allocation recommendations prior to the IAC's December meeting. At that time, LEAs will be given an opportunity to sign up to appeal their preliminary recommendation at the December IAC meeting.

In December, the IAC will consider and be asked to take action on the 75% IAC recommendations after hearing from the LEAs. From this approval, the IAC will publish the preliminary FY 2022 Capital Improvement Program, which will be provided to the budget committees of the General Assembly and other stakeholders. The IAC will be asked to approve the 90% CIP at its February meeting and the 100% CIP at its May meeting.

Background Information:

In the 21st Century School Facilities Act (2018 Md. Laws, Chap. 14; Education Article §5-310, Annotated Code of Maryland), the General Assembly mandated that the IAC contract with an independent third-party vendor to complete an initial Statewide Facilities Assessment (SFA) using the Educational Facilities Sufficiency Standards (EFSS) adopted by the IAC in May 2018. The purpose of the SFA is to obtain reliable and comparable data on the condition and educational sufficiency of each of the nearly 1,400 active K-12 public school facilities in Maryland in order to inform decision making around facilities planning, operations, maintenance, capital renewal, and, potentially, school construction funding.

On Sept. 23, 2020, the Board of Public Works (BPW) approved the IAC's \$5.8M contract with Bureau Veritas Technical Assessments, LLC (BV) of Maryland. On Sept. 30, IAC staff and BV staff launched the project and set a schedule to physically assess each active K-12 public school facility over the course of 10 months. IAC staff is pleased to report that the IAC's Statewide Facilities Assessment (SFA) is now in the pilot-assessment phase in which the assessment process is being tested on three pilot schools each in three pilot districts. In December, BV is scheduled to begin assessing the remainder of the facilities and continue doing so through June 2021.

Staff will continue to provide updates to the IAC as the project proceeds. The assessment and the data that will come from it are crucial to decision makers at many levels of State and local government and will substantially improve the effectiveness of the IAC in carrying out its mission of supporting a statewide portfolio of school facilities that are both educationally sufficient and fiscally sustainable so that they will serve the needs of Maryland well and serve them well into the future.
