DRAFT Meeting Minutes – November 18, 2021

Call to Order:

Chair Kasemeyer called the video-conference meeting of the Interagency Commission on School Construction to order at 9:01 a.m.

Members in Attendance:

Edward Kasemeyer, Appointee of the President of the Senate, Chair Superintendent Mohammed Choudhury, Maryland State Department of Education Secretary Ellington Churchill, Department of General Services Linda Eberhart, Appointee of the Speaker of the House Brian Gibbons, Appointee of the Speaker of the House Gloria Lawlah, Appointee of the President of the Senate Secretary Robert S. McCord, Maryland Department of Planning

Dick Lombardo, Appointee of the Governor

In Remembrance:

At the request of the Chair, Cassandra Viscarra, Acting Deputy Director of Administration, said a few words to honor the passing of IAC Member Denise Avara:

Today we take a moment to remember IAC Member Denise Avara. Denise lost a battle with cancer on October 19 at just 57 years old. She is survived by three sons, Christian, John, and Stephen, her husband, and her mother. We will remember Denise as a committed member to the mission of the IAC, serving as an appointee of the Governor, and a dedicated advocate for Maryland's public schools. The former president of the Westowne Elementary PTA in Catonsville, Denise developed an air conditioning initiative for the aging building which led to a grassroots effort for a completely new school that opened in 2016. Denise received a Comptroller's Medallion in 2015 for her advocacy and a Certificate of Recognition from the Comptroller in 2016 for her leadership with the PTA and her work on the Cool School Initiative. Denise also received a Maryland Hero Award for her service on the Comptroller's Educational Advisory Council. Denise leaves behind a lasting mark on her local community and the State of Maryland and will be greatly missed. Our thoughts and prayers are with her family and friends as they mourn this tremendous loss.

Upon a motion by Secretary McCord, seconded by Secretary Churchill, the IAC voted unanimously to approve the consent agenda.

A. Approval of the October 14, 2021 Minutes

D. Harford County Board of Education Site Approval

To approve the use by the Harford County Board of Education (HCBOE) of 61.04 acres of land at 900 South Main Street, Bel Air, MD, 21014 (Tax Map 49, Parcels P224 and P132), to replace the three-building Homestead/Wakefield Elementary School with a single facility with a scheduled completion in December 2024; adhering to the actions identified in the State clearinghouse review, State identifier 20210901-0715.

2. Built to Learn Project Approvals - [Motion Carried]

Arabia Davis, IAC Funding Programs Manager, presented recommendations for approval of nine Built to Learn (BTL) projects totaling \$263 million. To date the IAC has approved 14 BTL projects totaling \$283 million; with this approval the approved funding allocation for the state share of projects will increase to \$545 million. Upon questions and comments from Commission members, IAC staff clarified that the \$263 million will fund nine additional schools for a total of 23 approved BTL projects.

Upon a motion by Superintendent Choudbury, with a second by Ms. Lawlah, the IAC voted unanimously to approve projects as presented to be funded and executed through the Built to Learn Act, with allocations estimated to total approximately \$263,735,062. Final funding amounts are subject to adjustment based upon finalization of project worksheets and review of project eligibility.

3. Healthy Schools Facility Fund Presentation - [Informational Only]

Cassandra presented an overview and purpose of the Health Schools Facility Fund (HSFF) that was established by legislation in 2018 to address health and safety needs in school facilities.

4. Healthy School Facility Fund Project Approvals - Motion Carried

Kiaron Bailey, IAC Programs and Finance Administrator, provided a project summary of recommended HSFF allocations for fiscal years 2021 and 2022, totaling \$105.2 million. The funds will be used in projects that address concerns for HVAC, roofs, temperature regulation, windows, lead remediation, plumbing, and indoor air quality. Upon questions and comments from Commission members about reported Baltimore City heating and air conditioning problems from fall 2021, IAC staff clarified that HSFF funds and other funds such as the Capital Improvement Program and the 2019 extra \$15 million for Baltimore City HVAC



are being allocated to address Baltimore City's HVAC systems. IAC staff agreed to provide additional information to IAC Members on the status of Baltimore City heating and cooling.

Upon a motion by Ms. Lawlah, with a second by Ms. Eberhart, the IAC voted unanimously to approve the fiscal year 2021 and 2022 Healthy School Facility Fund allocations as recommended, including 50% of total FY 21 and FY 22 allocations to Baltimore City in accordance with Ed. Art., §5-322(j)(1)(iii) totaling:

- \$5,216,893 in recycled FY 2020 HSFF Funding
- \$30 million in FY 2021 HSFF Funding, including \$15 million to Baltimore City
- \$30 million in FY 2022 HSFF Funding, including \$15 million to Baltimore City
- \$40 million in FY 2022 American Rescue Plan Act (ARPA) Funding, including \$20 million to Baltimore City

5. School Safety Grant Program Application Period Extension for Baltimore City – [Motion Carried] Jamie Bridges, IAC Planning Manager, explained that during the July 8, 2021 meeting, the IAC approved the LEA allocations and release of applications for the fiscal year 2021 School Safety Grant Program (SSGP). All programs must be contracted before the end of fiscal year 2022 so a compressed application period was implemented; IAC staff provided information and reminders to LEAs to encourage submission of all SSGP project applications before the September 10, 2021 deadline. Due to an administrative oversight, a final reminder was not provided to Baltimore City Public Schools and further communication has shown that there are a number of projects that the LEA planned to complete with SSGP funds. Upon questions and comments, IAC staff clarified that no other LEA requires an extension as they have submitted their applications; this extension would allow Baltimore City to submit their application.

Upon a motion by Secretary McCord, with a second by Mr. Gibbons, the IAC voted unanimously to approve a 90-day extension of the School Safety Grant Program application period for Baltimore City Public Schools.

6. Washington County - Western Heights Middle Roof Contract Termination – [Motion Carried]
Robert Gorrell, Executive Director, presented a request to cancel the Western Heights Middle Systemic Renovation project contract with D Project Inc., which will allow Washington County Public Schools (WCPS) to reallocate funds and rebid the project at a later date. WCPS Representatives Jeffrey Proulx, Chief Operating Officer, Robert Rollins, Director of Facilities Planning & Development, and Patty Ursprung, Deputy Counsel, explained that WCPS staff recommended to the Board of Education to terminate the contract for convenience due to market conditions of the COVID-19 pandemic and rebid at later date when the market is more favorable.

Upon a motion by Secretary McCord, with a second by Ms. Eberhart, the IAC voted unanimously to approve the termination of the contract awarded to D Project Inc. for the Systemic Renovation project at Western Heights Middle (21.003.21 SR - Roof).

7. Washington County SSGP Reimbursement Extension Request – [Motion Carried]
Kiaron presented a request to extend the deadline for the Smithsburg High SSGP for reimbursement. The project faced delays due to challenges with obtaining fencing materials and COVID-19, but has since been fully expended.



Upon a motion by Secretary Churchill, with a second by Ms. Eberhart, the IAC voted unanimously to approve a request to extend the reimbursement extension deadline for the Smithsburg High School Safety Grant Program until September 30, 2021.

8. Delegate Authority to Grant Extensions - [Motion Carried]

Kiaron reminded the IAC that in June of 2020, the IAC granted the Executive Director authority to approve extensions for smaller programs for a year due to an increased number of extension requests from the LEAs, with many requests related to the COVID-19 pandemic issues. The IAC staff continues to see an increased number of extension requests and recommends that the IAC consider delegating authority to approve extensions to the Executive Director.

Upon a motion by Ms. Lawlah, with a second by Secretary McCord, the IAC voted unanimously to delegate authority to approve project extensions for projects funded through the Aging Schools Program, the Healthy School Facility Fund, or the School Safety Grant Program to the IAC Executive Director until November 30, 2022 so long as the extensions do not violate any legal requirement. Any granted extensions are to be reported to the Interagency Commission at their next regularly scheduled meeting.

9. Montgomery DuFief Elementary Built to Learn Project Cancellation - [Motion Carried]

Bret Waskiewicz, IAC Senior Regional Facilities Manager, presented a request to cancel the DuFief Elementary BTL project after the Montgomery County Board of Education adopted resolution to reallocate the funds to six other capital projects. Montgomery County Public Schools is dealing with a funding shortfall due to significant increases in construction costs and the DuFief Elementary School Project was identified as a cancellation that would address the issue.

Upon a motion by Ms. Eberhart, with a second by Secretary Churchill, the IAC voted unanimously to approve the cancellation of Montgomery County Public Schools FY 2022 DuFief Elementary Built to Learn replacement project.

Capital Improvement Program

Presentation to the Interagency Commission on School Construction

December 16, 2021

Capital Improvement Program (CIP)

- State's largest school construction grant program - averaging at least \$280 million/year recently, as allocated in the State's capital budget.
- Began in 1972 with initial funding of \$150 million.
- For major new, renewal, or replacement projects.
- For additions and capital maintenance (systemic renovations).
- Applications due annual in October, with revisions due in late November/early December (revision due date varies).



CIP Process



Local Education Agencies (LEAs) identify & prioritize project needs.

School boards then approve projects based on local project priority.



The County will provide notification of support for the local share of some or all of the submitted projects.



Local prioritized CIP projects are then submitted to the IAC.

Priorities are reviewed for eligibility by the IAC CIP team and assigned a recommended approval/deferral/denial status.

Allocations are projected based upon total anticipated funding in order of each LEA's highest eligible priority.



CIP Funding Phases

Staff recommendations for funding projections are submitted to the IAC.

IAC approves projects incrementally (as required by statute):



The 75% CIP allocations are released in December. 100% projections are provided.



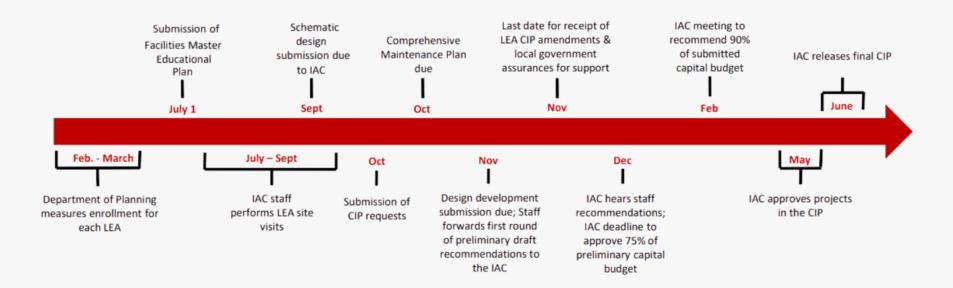
The IAC recommends allocation of 90% of the CIP to the General Assembly.



The 100% CIP allocations are approved by the IAC after May 1st and released for expenditure on July 1st.



Timeline





- Minimum project cost is \$200,000
- Projects in existing buildings must be older than 15 years and to support education programs and/or extend useful life of the system.
- Projects in replacement buildings must be supported by a feasibility study.
- Projects in new buildings must be needed to support enrollments.
- Funding for relocatables can be used for transfer to another site or to provide temporary classrooms during construction.

Eligibility



- The Built to Learn Act made planning and design costs eligible for State participation
- IAC adopted regulations that allow:
 - Planning: feasibility studies, programs, Ed Specs, equipment specifications, and other planning work prior to design.
 - Design: A&E fees, construction management services, geotechnical services, and other services necessary for architectural specifications.

Eligible Planning and Design Costs



Enrollment Growth and Relocatable Classroom (EGRC) Funding

Education Article §5-313 creates the **Enrollment Growth or Relocatable Classroom program**.

- Provides additional funding to LEAs with
 - An average of more than 250 relocatable classrooms over previous 5 years; OR
 - FTE enrollment growth that exceeds 150% of the statewide average over previous 5 years
- First \$40 million is allocated proportional to the full-time enrollment of all eligible counties
- Additional funding proportional based upon percentage of enrollment growth above the statewide average
- Required funding
 - o FY 2017 to 2026 \$40 million per year
 - o FY 2027 and after \$80 million per year

EGRC funding is allocated through the Capital Improvement Program



Procurement

Projects must be under contract within 2 years of IAC approval.

IAC must approve of all contracts.

Additional Construction Procurement methods consistent with COMAR 14.39.03.

Additional Project Delivery methods consistent with COMAR 14.39.04.

Payment

Direct payment to contractor or reimbursement to LEA.



Application

Documents are submitted via SharePoint.

The IAC releases annually an Instructions for Submission document for each CIP Fiscal Year:

This details the application requirements for all CIP project requests and additional documentation for different project types (capital maintenance, roof replacement, etc.).

Includes submission format requirements, such as naming conventions, file types, and how to indicate priority.

Amendments to applications:

- LEAs can submit amendments in late November/early December for projects for which information has changed.
- Written verification that the BOE supports revised priorities is required.

Amendments to prior year CIP:

Item 3. FY 2023 Capital Improvement Program 75% Project Approvals

Motion:

To approve the Fiscal Year 2023 75% Capital Improvement Program allocations and Planning Approvals for each school system and the Maryland School for the Blind as shown in the attached Summary of Project Requests and Recommendations and to authorize IAC staff to make adjustments to project allocations to avoid over and under funding of a project. Funding allocations to projects with a funding status of "U" are contingent upon resolution of outstanding issues.

Background Information:

Education Article §5-304(b)(2), Annotated Code of Maryland states:

On or before December 31 of each year, the Interagency Commission shall approve public school construction projects that comprise 75% of the preliminary school construction allocation, determined under §8-113 of the State Finance and Procurement Article, for the following fiscal year.

FY 2023 Capital Improvement Program Requests

On November 30, 2021, the Interagency Commission on School Construction received 189 requests for planning and funding as part of the Local Education Agencies FY 2023 Capital Improvement Program project resubmission totaling over \$998 million. Please note, that a number of these project submissions have been identified by the LEAs as requests for Built to Learn (BTL) funding. Those projects have been identified with funding status code "R" and are not considered for funding in this CIP. Built to Learn project approvals occur on a rolling basis and will continue to be brought to the IAC for review and approval as appropriate when the projects are sufficiently developed.

As IAC staff has done in the past, meetings and site visits were held over the summer with a number of LEAs to discuss their project pipeline, upcoming projects, general issues related to procurement management, contracting, local board and government policies, facility maintenance and conditions.

The IAC generally considers requests for planning approval and funding approval throughout the CIP process. For this round of recommendations, planning approval is only being recommended in December if the project is expected to receive the State share of eligible costs for a school construction project. Planning approval commits the State to fund a project

in unspecified future years. Additional planning requests will be considered and recommended in the May 100% CIP approval.

Staff's recommendations are based on total cost of ownership, the LEA's county-wide facilities portfolio, backlog of previously approved projects, and capacity to carry out approved projects. The LEA's 10-year average allocation amount has been used as a target for their overall allocation of new authorization, with variances as needed due to lower requests or higher needs. As in all previous years, the need to keep projects moving required some counties to receive more than their annual average.

IAC staff recommendations total \$156 million, or 75% of the preliminary school construction allocation of \$208 million, as outlined in the Governor's Preliminary Capital Budget. These recommendations are crafted to optimize the deployment of available State resources to leverage the greatest possible amount of work to be undertaken.

Some may require revisions to the December approval, which will be presented to the IAC at that time. Final recommendations for the FY 2023 CIP will be completed in mid-April for IAC review, with approval of final allocations to be made by May 2022.

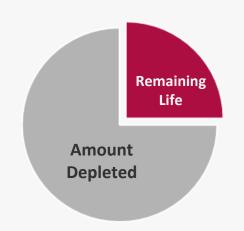

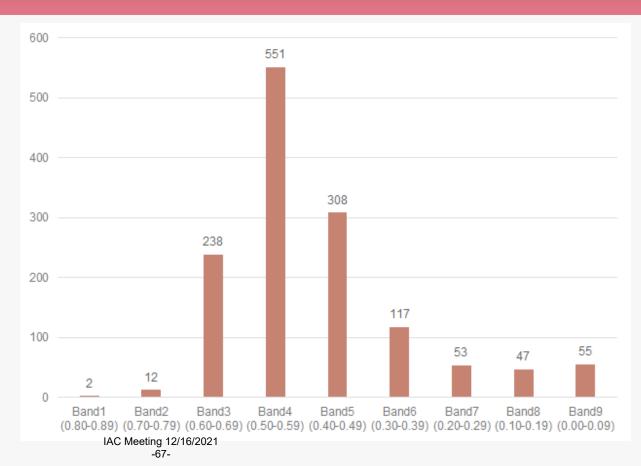

Statewide Facility Condition Distribution by Band

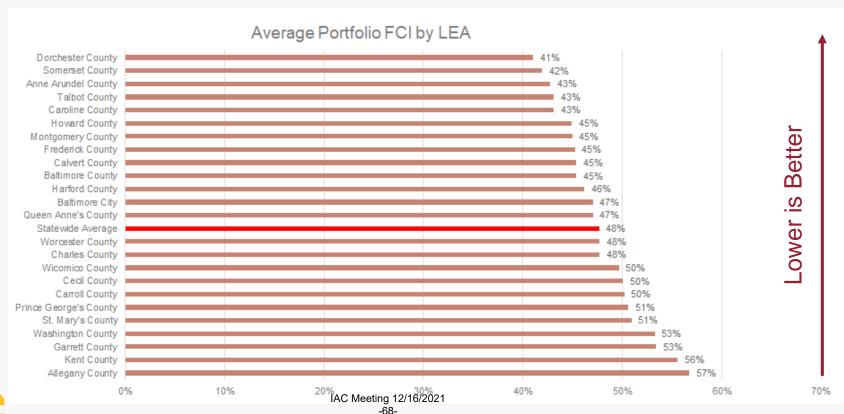

Workgroup Recommendations

Local Share Revolving Loan Fund

- Rename the fund as the School Construction Revolving Loan Fund
- Clarify in statute that funds may be used to forward fund State and/or local shares of projects that have received planning approval from the IAC
- Recommend \$50 million in PAYGO allocation in FY 23, \$20 million in FY 24, \$10 million in FY 25, and \$10 million in FY 26
- Priority given to counties that have not forward funded and that have limited debt capacity
- Require repayment with no interest within five years of loan disbursement





- Update the formula's components to align with Blueprint (Foundation formula and Guaranteed Tax Base)
- No changes at County level to enrollment growth, Free and Reduced Price Meals (FRPM), "One Maryland", local effort, and current State share minimum/maximum (50%/100%)
- New project-level components for Concentration of Poverty schools
 - 10 percentage points for schools with 80% or more FRPM

The Workgroup on the Assessment and Funding of School Facilities has not yet had sufficient time to discuss the various complexities of the <u>Gross Area Baselines (GABs)</u>. To support the ongoing conversation around the GABs, and the statutory charge of the workgroup to make recommendations regarding the GABs, the IAC wishes to provide to you and the membership the following information.

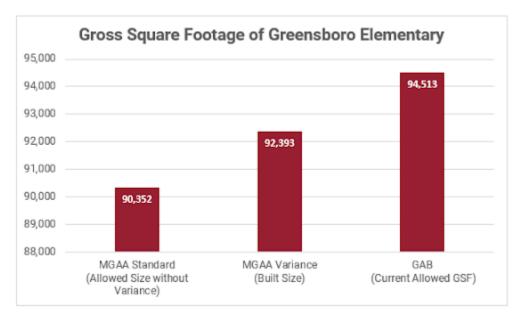
- On May 9, 2019, the IAC adopted new Gross Area Baselines to replace the IAC's Maximum Gross
 Area Allowances (MGAAs) and implemented a variance process by which the IAC may grant additional
 square footage allowances on a case-by-case basis with sufficient data from an LEA supporting the
 need for additional square footage.
- The new GABs were based upon extensive research, including side-by-side space tallies against MSDE's facilities guidelines, which were checked against schools built in Maryland since 1990. GABs were shared with LEA facility planners and adjusted as necessary. Key changes included:
 - All levels: Additional square footage for collaboration spaces and additional resource and student-support spaces.
 - Elementary Schools: Additional square footage for dedicated science spaces.
 - Middle Schools: Additional space for classrooms to support the scheduling and movement of students in groups to a greater extent than is undertaken at the high-school level; additional square footage for auxiliary gymnasiums at some enrollment levels; additional square footage for bleachers in regular gymnasiums.
 - High Schools: Additional square footage for Career and Technology Education (CTE) spaces to address the expansion of CTE programs; additional square footage for auxiliary gymnasiums at some enrollment levels; additional square footage for bleachers in regular gymnasiums.
- As a trial for the variance process, the IAC approved at its meeting on April 11, 2019 its first variance, one month before adoption of the new GABs. Caroline County, for its Greensboro Elementary School, was able to demonstrate that additional square footage was needed to provide its programs, particularly in light of the larger than average proportion (25%) of English Learner (EL) students. This was a variance to the MGAAs. However, as you can see in the below chart, the variance would have been unnecessary under the new GABs which would have provided more than the square footage needed by the LEA to provide its program.

- The IAC's Gross Area Baselines include additional square footage for Special Education students and CTE Programs, as well as for standalone or regional special education centers.
 - Students in grades 9 through 12 who are in CTE programs are assigned additional square footage per student above the baseline amount for a student in the proposed enrollment. The additional square footage per student equals 210 GSF minus the baseline GSF.
 - Special-education students in MSDE LRE categories C, S, and W are assigned additional square footage per student above the baseline amount for a student in the proposed enrollment. The additional square footage per student in grades PK through 8 equals 180 GSF minus the baseline GSF. The additional square footage per student in grades 9 through 12 equals 200 GSF minus the baseline GSF.
 - For example, the GAB per student for a middle school of 750 students is 141 SF. Special education students would generate an add-on of 39 SF per student.
 - Standalone and regional special education centers start at 300 SF per student and are reviewed carefully with the LEA and adjusted on a case-by-case basis to meet the needs of the students and the programs.
- It is critical that the IAC have some outer boundary of State participation with consideration of available statewide funding capacity, but also with consideration of fiscal sustainability required to ensure school conditions can be maintained over time.
- We believe that the IAC's adopted GABs provide a reasonable amount of square footage for LEAs to support the educational programs currently required by the State. However, we also understand that each school and each LEA face unique challenges. The variance process is intended to capture the needs of the LEAs so that the baselines can be adjusted based upon demonstrated needs both on a case-by-case basis but also at the Statewide level as precedence is established. The delivery of education will change over time and decisions to adjust the GAB, up or down, should be data driven.
- However, understanding that even requesting a variance process is a burden placed on the LEAs, the IAC recommends that, for a period of at least two years, a mandatory variance review process be implemented for any school for which the projected enrollment includes a greater than average (for the grade level) percentage of English Learner students, since there is currently not an add-on for this

Good afternoon, Superintendent Choudhury, Secretary Churchill, Secretary McCord, and Committee members Eberhart, Gibbons, Kasemeyer, Lawlah, and Lombardo.

I am in full support of this request, and I would like to thank you for the \$24.8 million of state funds already committed for school construction for FY2023, and the \$23.2 million of funding for the projects under the Healthy School Facility Fund.

While we appreciate this generous support, the FY2023 capital budget request addresses additional critical system needs, which I would like to take the opportunity to review with you.

It is our understanding that the first twelve priorities are being considered for Built to Learn Act (BTL) funding. We would, however, request the remaining eligible funding be allocated from the regular capital request to help supplement the BTL funding for those projects.

Baltimore County Public Schools (BCPS) is in the process of completing the largest ten-year construction program in Baltimore County's history. The \$1.3 billion Schools for Our Future program has upgraded and provided modern learning environments for tens of thousands of our children and teachers.

The results of this program are self-evident. With the assistance of both the state and the county, BCPS has been able to:

- air-condition the remaining 90 schools in Baltimore County that lacked central air conditioning in 2010,
- construct fourteen (14) new or replacement elementary and high schools,
- renovate and construct six (6) additions at elementary and high schools around the county, and
- replace aging roofs, boilers, chillers, windows, doors, and other essential building systems at numerous schools throughout the county.

The first twelve priorities, in the FY2023 Capital Budget Request include two replacement elementary schools, three high school replacement schools, and one high school addition project. All are projects are critical to meet our needs. The three high school replacement projects represent our pursuit of providing major improvements to our high schools and the needed high school capacity in the southwest and central areas of Baltimore County.

According to the July 12, 2021, memorandum from the funding programs manager, BCPS has been allocated \$7,137,000 in FY2023 CIP-Enrollment Growth and Relocatable Classroom

(EGRC) funds. This has not been allocated in the recommendations and we would greatly appreciate receiving these funds in addition to other CIP funding for the projects listed above.

This FY2023 Capital Improvement Program state funding request was based on ongoing dialogue with our state and county fiscal partners, the school Board, state and county elected officials, communities, and other stakeholders, and consists of our most critical needs.

In lieu of appearing before you we are submitting written testimony via this correspondence.

We would like to thank you for your support of our FY 2023 State CIP request. However, we do have some concerns with the timing of the recommended allocation of those funds. Our top priority project, the Town Creek Elementary School HVAC Systemic Renovation, is recommended for less than half of the requested funding in the first round and our second priority project, Lettie Marshall Dent Elementary School Limited Renovation, is only recommended for partial funding but not until the final funding recommendation in May. In order to ensure that these projects stay on schedule and do not end up potentially delayed by year, we respectfully request that the projected funding be allocated sooner in the process. Receiving a funding recommendation in December ensures that we can proceed with the bidding schedule in place.

In addition, we are concerned with the partial funding recommendation for Lettie Marshall Dent Elementary School. We were very conservative in our estimation of needed cashflow and would respectfully request that any additional available funding be applied to this project to ensure that it can move forward this fiscal year.

Thank you for this opportunity to appeal the recommended appropriation of \$4,160,205 in Fiscal Year (FY) 2023 Capital Improvement Program (CIP) funds for Washington County Public Schools (WCPS).

For the past 10 years, WCPS has averaged nearly \$8,000,000 in CIP funding each year. WCPS recognizes that the amount of funding available in FY2023 has decreased by nearly 25% from previous years, and realizes that most school systems throughout the state will experience a decrease in funding this year.

For FY2023, WCPS requested funding for nine (9) systemic renovation projects. Of those nine (9) projects, the current recommendation fully funds the State portion of only one (1) project, and partially funds one (1) other project.

Our request is modest:

WCPS appeals to the Interagency Commission on School Construction to fully fund its request for the Smithsburg Middle School Roof Replacement project, which is currently recommended for partial funding.

This request would result in WCPS receiving a total of \$5,496,000 in FY2023 for its capital replacement needs. This amount represents approximately 69% of the amount traditionally received by WCPS, while securing funding for (2) complete projects that could then move forward.

Both of these projects have local government support to fully match the State funding if it were to be made available.

Thank you again for your consideration of this modest request to benefit the students and citizens of Washington County.

We appreciate your support and assistance in implementing the on-going goals of our Capital Improvement Program. We especially thank you for the approved 75% FY2023 allocation for our top priority project, the Renovation & Addition of Mardela Middle/High School. While this first allocation of \$5,788,112 and the subsequent 90% and 100% funding recommendations are anticipated to total \$8,212,737, we understand CIP allocations are contingent on the Final Capital Budget amount and IAC approval. We are pleased to see the IAC's additional recommended allocation of \$1,787,263 bringing the full 100% recommended allocation to \$10,000,000 but also understand this is contingent on available prior year appropriations and IAC approval.

The Renovation & Addition of Mardela Middle/High School was approved for local planning in FY2021 and FY2022 request for construction funding was deferred. Wicomico's FY2023 request is for \$25,815,508. This includes an anticipated \$13,815,508 in Built to Learn (BTL) funding, which we are working with the Maryland Stadium Authority (MSA) to secure, in addition to \$12,000,000 requested in FY2023 traditional CIP funding. At 100% State Cost Share, it's imperative we receive the full 100% recommended allocation of \$10,000,000 to maintain critical construction milestones.

As discussed in detail with the IAC staff, Wicomico is already under contract for Construction Manager at Risk with Design-Assist. Projected cashflow needs in FY2023 for critical Phase 1 of construction is \$30,367,196. Local government is currently forward funding project early bid packages.

On behalf of the students, staff, parents and various community partners of Wicomico County Public Schools, thank you for your time and consideration.

FY 2023 CIP Appearance Testimony Made before the Interagency Commission on School Construction – via Webex Calvert County Public Schools December 16, 2021

Good Morning,

We appreciate the opportunity to appear before members of the IAC today, to discuss and review Calvert County's funding requests for the FY 2023 Capital Improvement Program. There are 3 projects that encompass our FY 2023 CIP. We appreciate the IAC staff's 75 percent recommendations to fully fund our Priority 1 and 2 projects. Furthermore, we understand that budgetary constraints are the reason that our Priority 3 project request has been deferred.

Today, we would like to take the opportunity to highlight the importance of all these projects, not only to assure the level of support currently projected, but also to request that you reconsider funding them fully. Of the 3 requests, 2 are systemic renovations, focused largely on HVAC. We have always known that systemics are a key component to operating our buildings effectively and efficiently, but never has it been more apparent, than now. In light of COVID-19, we must ensure that our HVAC systems are fully operational and sufficient outside air and ventilation is delivered within instructional spaces.

Our first project request is for the second and final year of funding for the Beach Elementary School Replacement project. We appreciate the IAC's commitment to this project, evident through the funding provided in FY 2022. As Dr. Curry mentioned earlier, we recently broke ground on the Beach Elementary School project and expect completion by end of 2023. Last year, State funding for the project consisted of \$10,666,000 and this year we are respectfully requesting the full balance of funding in the amount of \$4,189,000, so we may complete the project.

Our second request is a systemic renovation project at Calvert Elementary School consisting of the replacement of HVAC equipment dating back to the 1964 original building and the 1974 addition. The project scope includes replacement of the 1964 roof, which is original to the building. The existing equipment and roof that encompass the project scope are 47 to 57 years old; well past their

remaining useful life. The new HVAC equipment will be energy efficient and operate via direct digital controls or DDC. This project was requested as a Priority 3, within the FY 2022 CIP and received \$218,495 of the \$1,487,180 requested. We have included it within our FY 2023 CIP and respectfully request the balance of the State share in the amount of \$1,268,685.

Our third and final request, which we are appealing today is for an HVAC Systemic Renovation Project at Plum Point Middle School. The 3 DX Rooftop Units, 11 Air Handling Units, and 100 VAV boxes are original to the 1992 building, experience frequent problems, and don't adequately control humidity. The VAV boxes are non-fan powered, pneumatically operated, and have been repaired numerous times. Because they are unable to be retrofitted, they will be replaced with the project scope. All the new equipment will be energy efficient and operate via DDC controls. Due to the large scope, the project will be phased over 2 summers, and requires a total of \$4,432,000, with a total State allocation of \$2,425,920. Our funding request for the first year is \$1,895,920. This project was included as a Priority 5, in Calvert's FY 2022 CIP, but was deferred by the IAC due to fiscal constraints. We respectfully request that reconsideration be given to funding this critical project with the current CIP cycle. Design is currently 50 percent complete, and assurance of funding would allow the project to be bid in ample time to procure equipment and begin Phase 1 work in summer 2023.

In closing, we appreciate the support the IAC has given to Calvert County in the past. Your continued support will ensure that Calvert County can provide safe, healthy, and well-maintained facilities for our staff and students.

PGCPS IAC FY23 CIP Appeal Testimony

Good Morning Members of the Interagency Commission (IAC) and staff. My name is Dr. Monica Goldson, and I am the CEO of Prince George's County Public Schools (PGCPS). I am here today with staff members Mr. Shawn Matlock, Director of Capital Programs, and Ms. Shayla Taylor, Capital Programs Supervisor.

Thank you for inviting us this morning and for the 5 projects that received an 'A' or 'U' status with recommendation for full funding. We are looking forward to delivering these projects to our county's students and appreciate the \$1.8M that funds the balance of our Priority 1 and Priority 2 projects (respectively, the William Wirt Middle School replacement facility and the New Glenridge Area Middle School) and the \$21.9M that fully funds the three systemic projects that represent our Priority 10, 11 and 12 in this FY23 CIP.

However, we are here to appeal our Priority 4 project--the critically needed modernization of the Suitland High School campus--which is currently recommended for zero of the \$27.5M requested State dollars. The "U" status indicates outstanding issues although no issues were identified in the "CIP Issues Letter" from the IAC staff dated December 2, 2021. This project is distinctly important to our County and is scheduled to begin construction in the summer of 2022 dependent on State funding. The existing Suitland HS facility houses the Center for Visual and Performing Arts (CVPA) program as well as the more than 1500 students in their comprehensive high school program. The 1950s era main building and the CVPA converted middle school building are both in poor condition. Temporary, structural remediation work was recently completed with local funds to ensure the safety of the students and staff until the new building is

constructed. Delays in funding approval ultimately delay occupancy of the new building and

demolition of this structurally compromised building.

Furthermore, our total request for FY22 is \$51.3M and the recommended \$19.3M plus \$4.5M in

Enrollment Growth in Relocatable Classroom (EGRC) funding is significantly less than our

10-year average allocation for the 3rd year in a row. Because of this, each year our 10-year

average continues to decline even though we have been recognized as one of the LEAs with the

greatest need. The annual allocation should be closer to \$40 million each year plus the additional

Enrollment Growth in Relocatable Classroom (EGRC) funding to relieve overcrowding.

In conclusion, please consider increasing our Suitland HS construction funding allocation from \$0

to \$27.5M so that PGCPS can maintain the project construction schedule and receive a State

funding allocation closer to the 10-year average.

Appeal of Montgomery County Public Schools to the Interagency Commission on School Construction Funding Recommendations For the Fiscal Year 2023 Capital Improvements Program

December 16, 2021

Good morning Mr. Choudhry and members of the Interagency Commission on School Construction (IAC). I am Dr. Monifa B. McKnight, interim superintendent of schools, for Montgomery County Public Schools (MCPS). Joining me today are Dr. Eugenia S. Dawson, chief of finance and operations; Mr. Seth P. Adams, director of facilities management; and, Ms. Adrienne L. Karamihas, director of capital planning and real estate. On behalf of the members of the Board of Education, thank you for this opportunity to present our appeal of the IAC staff recommendations on the Fiscal Year (FY) 2023 state school construction funding for MCPS.

The Montgomery County Board of Education's FY 2023 State Capital Improvements Program (CIP) request is \$229.45 million. This amount is based on current eligibility of projects approved by the Montgomery County Council in May 2021. This state aid request represents projects that will be funded through the *Built to Learn Act of 2020*, as well as through the statewide annual CIP submission process.

Of the request, \$30.29 million is for 20 systemic roofing and Heating, Ventilation, and Air Conditioning (HVAC) and Roof Replacement projects to be funded through the annual CIP submission process; \$18.28 million is for 3 capacity projects identified to be funded through the annual CIP submission process; and \$180.88 million is for 1 new elementary school, 1 high school reopening, and 6 major capital projects identified to be funded through the *Built to Learn Act* program.

We anticipate that some project totals may be adjusted to maximize the *Built to Learn Act* funds. MCPS staff will continue to collaborate with IAC staff as we work through this new process. We also appreciate the flexibility provided to allow school systems to reconsider the funding source, either the annual state allocation or the *Built to Learn Act* funds, in order to maximize state construction funds for our capital projects.

Many of our schools significantly are overutilized and also require investments in aging infrastructure, and the capital projects identified in the *Board of Education's Requested FY 2023 Capital Budget and FY 2023–2028 Capital Improvements Program* will address our growing need for classroom space through additions and new schools and improve our aging facilities and infrastructure through major capital projects and countywide systemic projects. The COVID-19 health pandemic also has highlighted the importance of funding our HVAC replacement program and the need to maintain a more consistent upgrade and replacement schedule.

On November 15, 2021, we received the annual issues letter that identified outstanding questions and issues as a result of the Designees review of our state CIP submission. Our responses to those questions were forwarded to Mr. Robert A. Gorrell, executive director, IAC on November 30, 2021, and are incorporated in our Revised FY 2023 State CIP request submission. We believe that there is adequate justification for all of the funds included in the request, with the exception of one roof replacement project that did not meet the age requirement for replacement, and therefore, will be included in our state aid submission for FY 2024. With the removal of the

one Roof Replacement project and a technical adjustment to include one addition project with prior year funding with remaining construction funds, our Revised FY 2023 State CIP request is \$231.26 million. The IAC staff recommendation is to initially fund \$19.25 million of our \$231.26 million request. Therefore, we are appealing the balance of our request that was not recommended for state funding.

Specifically, with respect to our systemic projects, we are appealing the balance of funding for 6 HVAC projects and 10 Roof Replacement projects that received only partial funding from the IAC staff. In addition, we are appealing for the full funding for 3 Roof Replacement projects that did not receive any state funding as part of the IAC staff recommendation.

With respect to capital projects, we have received approval for *Built to Learn Act* funds for the following projects.

- Charles W. Woodward High School Reopening
- Clarksburg Elementary School #9
- Burnt Mills Elementary School Major Capital Project
- South Lake Elementary School Major Capital Project
- Woodlin Elementary School Major Capital Project

As previously noted, some project totals may be adjusted based on construction cost increases and prevailing wage rates. We, therefore, will continue to work with IAC staff to finalize the allocation of state funds for these important projects.

The IAC staff recommendation does not recommend funding for any of our remaining capital projects; therefore, our appeal includes the following six capital projects:

- Dr. Ronald E. McNair Elementary School Addition
- Parkland Middle School Addition
- Neelsville Middle School Major Capital Project
- William Tyler Page Elementary School Addition
- Poolesville High School Major Capital Project
- Stonegate Elementary School Major Capital Project

With respect to these six capital projects not recommended for construction funds, we will continue to collaborate with IAC staff to determine which funding source, whether the annual state allocation or *Built to Learn Act* funds, will be utilized to maximize our eligibility for state dollars.

With the need to provide permanent seats for our student population and to address the aging inventory of older school facilities, funding for our CIP continues to be a complex issue. Local funding sources, such as county General Obligation Bonds, current revenue, and the county Recordation and School Impact taxes are utilized in conjunction with state aid to fund our many capital and systemic projects. We do know that some of our capital projects included in our state aid submission will be considered through the *Built to Learn Act* funding; however, we understand that the IAC staff will review all projects, regardless of state aid funding source, and therefore want to stress the importance and need for the many capital and systemic projects included in our request.

Montgomery County Public Schools has seen a steady increase in enrollment from the 2007–2008 through the 2019–2020 school years. However, the COVID-19 health pandemic has impacted our student enrollment, as well as the student enrollment of many public schools across the country. The official September 30, 2021, enrollment is 158,232, a one-year decrease of 2,332 students. While this represents a second year of a decline in student enrollment, the decline is at a slower rate than MCPS experienced from the 2019–2020 school year to the 2020–2021 school year. We believe in the near future, we will experience student enrollment growth, similar to our experience, prior to the COVID-19 health pandemic.

Total school system enrollment is projected to increase to 166,160 students by the 2027–2028 school year. This projection represents a slight slowdown in enrollment growth in part due to the continued decline in resident births, which results in lower kindergarten enrollment and smaller cohorts of students as they progress through the school system each year. In addition, our enrollment projections do account for the current health pandemic. We believe this decline in enrollment will be temporary and, therefore, the capacity projects included in the *Board of Education's Requested FY 2023 Capital Budget and FY 2023–2028 Capital Improvements Program* still are warranted and must remain on their approved schedules and this cannot be accomplished without funding from the state.

It is crucial that our state aid request be approved in order to meet the substantial capital funding needs for MCPS. We appreciate the past support for state school construction funding in Montgomery County. We look forward to working with you to ensure that the students of our county continue to learn in well-designed buildings that accommodate enrollment and provide the educational programs of which we are very proud. Thank you for your time and attention to our concerns and for your consideration of our state aid request.

Talking Points

Introduction

- Good Morning Mr. Choudhury, Interagency Commission on School Construction (IAC) Members, and Mr. Gorrell. On behalf of the Baltimore City Public Schools' (City Schools) Board of Commissioners and the Chief Executive Officer, I thank you for the opportunity to address members of the IAC about City Schools' Fiscal Year (FY) 2023 capital improvement priorities.
- We are present today to appeal the IAC Designees' FY 2023, 75% CIP recommendations for City Schools. City Schools FY 2023 request includes twenty-two (22) projects totaling approximately \$54 million in state funds. The FY 2023 request consists of seven (7) major projects, three (3) of which are renovation/addition projects for Armstead Gardens EM, Maree G. Farring EM, and Benjamin Franklin HS (planning). The remaining four (4) major projects include the replacement of Furley E, renovating the Northeast building, structural repairs at Roland Park EM, and planning for the renovation of Edmondson H. The FY 2023 request also includes fifteen (15) systemic projects that consist of much needed repairs to various building systems such as, but not limited to, HVAC, windows, fire alarms, elevators, and roofs.
- On November 30, 2021, City Schools submitted a written response to the FY 2023 CIP Issues
 Letter and supporting documentation to address any outstanding concerns. An amended FY 2023 CIP was not required.
- As with previous years, the FY 2023 CIP request just begins to address the capital renewal needs
 necessary for the long-term viability and preservation of our aging and newly renovated or
 replaced physical infrastructure.
- We greatly appreciate and thank the IAC for the \$18.9 million (based on 75% authorized funding) recommended for City Schools FY 2023 CIP requests, in addition to the projected additional \$5.35 million in 100% authorized funding.

 We will use the rest of our time to appeal the FY 2023 CIP project requests that were not recommended for funding or not recommended for full funding. In addition, we will share with you some of our accomplishments, and the challenges City Schools faces regarding our capital planning and facility maintenance needs.

FY 2023 CIP Appeal

- As Baltimore City Public Schools has undergone movement in the district over the past year, we would like to stress the importance of state support toward improving school facilities for Baltimore City students. Per the 75% IAC staff recommendation, five (5) projects were recommended for approval for \$18.9 million. However, 17 projects were not recommended for approval, and four (4) projects were not recommended for full funding. Below illustrates the current status of major projects and systemic projects that were not approved or not fully funded, and why City Schools appeals each of the projects:
 - Northeast Building #49 (Renovation)
 - The IAC allocated planning approval in the FY2021 CIP for this project. The Vanguard program has been housed in the Thurgood Marshall building since 2015 as swing space due to the inadequate facility conditions of the Northeast building.
 - The renovation project will accommodate 591 middle school students as one of the three stand-alone middle schools in the district.
 - The renovation will also accommodate 300 additional priority 1 middle school students (who are usually unplaced) through the middle school choice process.
 - Completing this project will assist in vacating the Thurgood Marshall building. When the Northeast and Furley buildings are renovated, and the Vanguard and Furley programs return to their original buildings, the Thurgood Marshall building will be surplused to Baltimore City.
 - A total of \$5,000,000 were requested for this project. The IAC recommended partial funding for this project for \$2,504,000.

- The recommended partial funding will not adequately address the needs of this project. Fully funding the project is needed to complete the project in a timely fashion. The completion time of this project must align with the proposed schedule for surplusing the Thurgood Marshall building, as reflected in Exhibit 6 (current portfolio recommendation for surplusing the Thurgood building is revised from 2023 to 2025).
- Benjamin Franklin H #239 (Planning for Renovation/Addition)
 - Local planning is requested for this project to support Baltimore City Public Schools' Career and Technology Education (CTE) 4-year Career Readiness Plan. By SY2024-25, the goal is to offer three new pathways to future students who attend Ben Franklin High School.
 - Planning approval is required to proceed with the project and ensure that the construction is complete and that the pathways are in place according to the schedule.
- Edmondson HS #400 (Planning for Renovation/Addition)
 - Local planning is requested for this project to support Baltimore City Public Schools' Career and Technology Education (CTE) 4-year Career Readiness Plan. The plan's objective is to align high-wage and high-skill jobs with City Schools CTE programs. By SY2024-25, the goal is to offer four new pathways to future students who attend Edmondson-Westside Vocational Technical High School. In addition, the plan is to house the CTE programs in one building. Currently, CTE spaces are located in the Westside building, and classroom spaces are located in the Edmondson building.
 - Planning approval is required to proceed with the project and ensure that the construction is complete and that the pathways are in place according to the schedule. In addition, this project will help to confirm that the CTE programs function more efficiently in one building.
- o All other fifteen (15) systemic projects not recommended for approval

- The systemic improvements are identified as City Schools' most critical systemic capital projects. These systemic renovations focus on improvements throughout Baltimore City that are required to maintain the structural and functional capabilities of the schools. In addition, they address urgent needs that cannot be delayed until the schools are replaced or renovated to ensure the continued occupancy of these schools.
- Completing the systemic projects will provide improved learning and working environments and increase energy efficiency.
- Fully funding all of the requested systemic projects is important to address critical school facility improvements needed in Baltimore City.

City Schools Accomplishments

- As we appeal all projects that were not recommended for funding, we would like to highlight
 progress and positive results made over the last few years related to City Schools facilities.
- The COVID-19 pandemic has brought unprecedented challenges to students, school districts, and community stakeholders. As a result, innovation and collaboration are more important than ever before. We will highlight positive progress and results City Schools has made over the last few years and discuss district-wide plans that may impact our CIP request and considerations.
- Baltimore City Schools Air Conditioning efforts were significant this year. We have installed air conditioning through the five-year Air Conditioning Plan in approximately fifty-six (56) non-air-conditioned buildings. New 21st Century buildings, new CIP constructed buildings, full HVAC systems, and installing vertical packaged units are some methods used to provide air conditioning. In addition, we developed a private-public partnership with the Ravens NFL, our local football team, who provided support for two of the vertical packaged unit projects. The last few air-conditioning projects all have plans to have air-conditioning installed in the next year (except a few major projects that have suffered due to lack of funding).
- City Schools is at 85% utilization rate for district-owned buildings in SY2020-21.

• City Schools has surplused 25 buildings, totaling 2.1 million square feet and 12,120 seats, since the beginning of the 21st Century Buildings Plan.

City Schools Challenges

- While City Schools has made significant progress, the need for our facilities is still excessive. City Schools has approximately 17 million square feet of facility space and 149 buildings in our portfolio. The capital cost to appropriately address the aging buildings in our portfolio is approximately \$200 million per year. The cost is calculated using the current replacement value of 4% of \$5 billion. The four percent includes upgrades to existing facilities, reduction in the accumulated backlog of deferred maintenance resulting in full system replacement needs, and altering existing facilities to address educational adequacy. Unfortunately, 80% of the portfolio remains without funding for replacement or renovations.
- The Baltimore City School Board of Commissioners reviews and considers recommendations to utilize our aging and underutilized facilities more efficiently with limited resources.

Closing

- In closing, City Schools thanks you again for your continued support in addressing the facility needs of Baltimore City Schools.
- I want to reiterate City Schools' need for state funding and support with capital projects is great.
 We continue to look to the state to assist in providing the necessary resources to jurisdictions.

APPEAL TO INTERAGENCY COMMITTEE FOR PUBLIC SCHOOL CONSTRUCTION

On behalf of the Board of Education of Cecil County, we submit these comments in support of our FY 2023 Capital Improvement Plan. We appreciate your continued efforts to make public school construction funds available to those jurisdictions with the most pressing needs. The following projects have been submitted for your review and approval. We would like to make an appeal for each one individually as our county continues to struggle with high priority needs and an ever increasing deferred maintenance list.

1. North East Middle/High School Replacement – Local Planning Request

In the FY 2021 CIP, CCPS received Local Planning support for the North East Middle School Replacement Project. This project was proposed to be constructed on a recently purchased site adjacent to the existing North East High School. In the process of planning for this project, our Superintendent and our local County Executive showed their support for an alternative project. This alternative project determined that addressing a replacement North East High School, which is currently in the CCPS 5-year plan, in combination with our replacement North East Middle School, would allow us to improve our overall school facility portfolio more efficiently and lower our Total Cost of Ownership for both buildings. This alternative project received a Feasibility Study waiver approval from Mr. Jamie Bridges on September 2, 2021. Educational Specifications have been submitted and are currently being reviewed. We respectfully request that you recommend local planning approval for the North East Middle/High School replacement project.

2. North East Middle/High School Replacement – Design Fees Request

As we are anxious to continue to keep the momentum moving forward on this exciting project, CCPS has engaged the services of Grimm & Parker Architects to design the North East Middle/High School replacement project. In conjunction with Local Planning approval, and while we are thankful for the initial partial design fees funding of \$2,255,527, we respectfully request that you recommend the additional \$1,744,473 of the FY23 CIP submission. We respectfully request that you approve the State share of design fee funding in the total amount of \$4,000,000 so this project can continue with full A&E design.

3. Elkton Middle School – Roof Replacement

We are continuing to tackle ongoing deferred maintenance issues with this systemic renovation request. The scope of work is a full roof replacement on the school. It is important to note that this request was deferred in last year's 2022 CIP request due to lack of funding. This roof has the highest FCI score in the most recent State Wide Facilities Assessment Report for Cecil County. Continuing to defer this project jeopardizes the condition of the school, not to mention the safety of faculty and students. We respectfully request that you approve the State share of funding in the amount of \$1,376,000 so this project can proceed.

Conclusion

We wish to recognize the significant commitment on the part of the State of Maryland, Cecil County Council, and Board of Education of Cecil County to improving our school facilities. Both the County and State should be commended for this financial commitment, especially in light of competing fiscal needs.

We find ourselves, however, in the unfortunate position of being a low-wealth county with aging buildings and newly mandated programs. Our long-term strategic goal for the capital improvement plan is to decrease the total amount of deferred maintenance across our county, while improving the instructional environment for our students and staff. The 30+ superior ratings on state inspections we have received over the last 20 years proves that we are excellent stewards of tax dollars and remain a good investment for our State.

We thank you for providing us this opportunity to address school facility improvement needs in Cecil County. We hope you will give careful consideration to these comments in your very difficult deliberations.

Dear Mr. Gorrell and Members of the Interagency Committee on School Construction:

On behalf of the Board of Directors and The Maryland School for the Blind (MSB) Leadership Team, I offer our sincere thanks for your consideration of this appeal.

As you know, this construction project includes Phase V of the MSB Campus Master Plan. This is primarily a new residential facility that includes the replacement of Randall and Thompson dorms, but it also replaces the Bledsoe building, which houses the Maryland Instructional Resource Center (MIRC)--the Maryland braille book repository. Our progress on the Campus Master Plan to this point simply would not have been possible without the support of the IAC. Moreover, since MSB's eligibility for IAC Public School Construction funding expires in 2028, we need to determine the path forward to keep our Master Plan on track in spite of the unprecedented high costs of construction and materials during the pandemic.

I will not restate the full justification for these projects here since it has been addressed in the CIP submission and in numerous documents presented in previous years to the IAC, except to say this: Maryland's blind students need appropriate and accessible educational and residential facilities. Maryland's braille textbooks, which reflect hundreds of thousands of dollars in costs shared by the twenty-four jurisdictions, are under constant threat of damage due to Bledsoe's leaky roof and windows. The Thompson and Randall dormitories and the Bledsoe building in particular were constructed pre-ADA, over 40 years ago, are unsuitable for the current student enrollment, many of whom have multiple disabilities and physical needs.

The investment in new construction versus the estimated \$4M in anticipated maintenance costs over the next 10-years as reflected in our 2020 facilities study by replacing the aging Randall, Thompson dorms and the Bledsoe braille textbook building is an important action of stewardship of MSB's and the State's since there limited resources which would be better used for providing accessible facilities in the provision of a rich, and federally mandated, educational program that we provide for Maryland's vulnerable and often underserved blind students.

There are funding challenges to this project, but ultimately, MSB Leadership is solution-focused and committed to working collaboratively with the State to bring our Campus Master Plan to completion.

Our appeal is to increase the net state funding for the Residential Cottages to \$26.8M and to increase the annual allocation to \$9M.

MSB's October 2021 CIP construction costs were based on SD estimates which came in at \$23.2M. The state share was calculated at \$21.5M (93%) and MSB share \$1.7M (7%). The draw schedule we requested was

\$7.1M annually. The reality is that we're in a volatile market. Our design consultants put together a good faith estimate that didn't include the latest market information. And now our contractor has prepared our DD budget, and tested the market accordingly.

As a result, when we received the DD estimates on December 6, the costs had increased by \$5.6M from the SD estimate. The total construction cost is now estimated at \$28.8M—the state share being \$26.8M and MSB share at \$2M. The revised draw schedule request is now \$9M annually.

This substantial increase in costs necessitates a revision of the CIP proposal, which we have requested.

In the meantime, the MSB Board of Directors and Leadership have developed a preliminary cash flow plan with pre-approval for a bridge loan, principled use of MSB's endowment assets as well as investigating prospective grants and fundraising opportunities.

However, without sufficient funding from the state, by far the largest source of funding, it will not be feasible for MSB to continue this important work.

Related to this project, MSB is revising the 2014 Campus Master Plan. Since 2014, MSB has made significant progress with the campus renewal. However, there is still important work to be done through the final projects (the cottages, pool and gym) which need to be addressed before our time in IAC funding sunsets in 2028. The completion of this work is essential in order for MSB to continue to serve its current students and fulfill its critical mission and the federal and state requirements under IDEA to educate all of Maryland's current blind students as well as future generations of students to come.

With an updated Master Plan and cost projections, MSB will be in a better position to work with the IAC and bring the rest of our plan to completion over the next 7 years, when eligibility for IAC funding expires. However, we cannot afford to wait for completion of the Master Plan, as a delay in this work will be devastating for the students that we serve.

The MSB Board and Leadership Team have done their best to be good stewards of state funds, to be thoughtful and prudent in our planning and implementation of our work and ultimately to be good fiduciaries of state and local resources. We have invested state funding in local and state companies to ensure that state monies are reinvested locally.

We look to you for guidance as we address this significant challenge and opportunity to bring the Campus Master Plan to fruition.

Good morning. I am Brad Young, President of the Board of Education of Frederick County. We appreciate the opportunity to speak with this Commission about our FY2023 capital funding requests.

This year, Frederick County Public Schools has a September 2021 total enrollment of 45,300 students; a growth of more than 2,000 students from the September 2020 enrollments. After a decrease of almost 680 students last year due to the impacts of virtual learning necessitated by the pandemic, FCPS enrollments are again climbing due not only to the return of students who chose home instruction or private schools last year and those who delayed enrollment in kindergarten, but also to a robust residential housing market and in-migration of families to Frederick County. This growth in enrollments is expected to continue for the foreseeable future with an anticipated total enrollment of almost 46,360 students for September 2022.

Our need for additional classrooms is critical. Enrollment projections for next year indicate that 23 of our 68 schools will be over 100% of state rated capacity, with nine of those schools over 120% of capacity. Capacity needs are found at all schools serving the high growth areas in Frederick County along I-70, I-270 and both the east and west sides of Frederick City.

In addition, our school portfolio is aging. Of our 12 schools originally constructed more than 60 years ago, nine have had only minor systemic projects. The other three buildings more than 60 years old have had major renovations, but that was more than 30 years ago. There are 27 additional school buildings between 30 and 60 years old, 24 of which have had only minor renovations or systemic projects. FCPS has been delayed in meeting our renovation and replacement needs because of competing needs for additional space and limited capital funds from the state.

The Board of Education of Frederick County is fortunate to have an excellent relationship with our County Executive and Council. The County has had a long practice of forward funding the state's share of school construction costs so that we can move projects forward to meet our ongoing capacity and renovation needs without waiting for the state to fund the project in its entirety. However, the County's ability to continue to forward fund school construction projects is dependent on the state meeting their funding commitment in a timely manner. We urge you to fully fund our requests for these projects this year, and if additional funding becomes available, to fully fund the state's commitment for these projects.

In closing, Frederick County Public Schools continues to do its part to be good stewards of taxpayer dollars and to address the funding challenges associated with school construction needs. Our approach to school construction utilizes best management practices while also looking outside the box and strategically employing new methods to reduce construction costs.

Good morning. I am Paul Lebo, Chief Operating Officer of Frederick County Public Schools. We appreciate the opportunity to speak with you about our FY2023 capital funding requests.

As President Young stated, school capacity needs have been a critical concern for FCPS over the past several years. This is where we have recently directed much of our capital resources by opening a new Sugarloaf and Butterfly Ridge Elementary School, a larger Urbana Elementary School replacement in 2020, and a new Blue Heron Elementary School in 2021. We continued to address capacity issues with the construction of a larger Waverley Elementary School replacement scheduled to open in 2022 as well as the construction of a larger Brunswick Elementary School replacement.

While additional capacity continues to be a priority for FCPS, we have also placed a priority on renovating our oldest schools. Our request for FY2023 includes the remaining funding for the Thurmont Elementary School limited renovation project as well as for local planning approval and funding for the Monocacy Elementary School limited renovation project.

The Thurmont Elementary School limited renovation design began in FY2022 and is on schedule to begin construction in Spring/Summer of 2022 with completion the following summer. This is the first school to be modernized in our limited renovation program. Monocacy Elementary School is the second school in our limited renovation program. This 32year-old school has had no renovations except for minor systemic improvements since originally constructed.

We are requesting both local planning approval and funding for the first phase of the Monocacy Elementary School limited renovation project. The IAC staff summary of recommendations for 75% of the FY2023 funding categorizes this project as U indicating that there are outstanding

issues. It is our understanding that the project was classified this way because the educational specifications for this project are still under review. We fully expect that IAC staff will approve the ed specs and urge the Commission to grant local planning approval for this project as well as the requested funding.

In addition to the request for capital funds to pay back previously approved projects that were forward funded by the County, we have also requested funding for the replacement of the original 31-year-old roof at Ballenger Creek Middle School. Again, we urge the Commission to fund this request as recommended by the IAC staff.

Finally, I would note that there are two other projects included in our FY2023 capital program for which we will be requesting funding with monies from the Built-to-Learn Act. These two projects, the replacement of Green Valley and Valley Elementary Schools, are essential in meeting both our renovation and capacity needs. With a state rated capacity of 499, Green Valley Elementary School is currently at 138% of capacity. It is anticipated that Green Valley Elementary School will be at 158% of capacity, or in need of 300 additional seats, next school year. In addition, Green Valley Elementary School is a 50-year-old building with no significant renovations. It currently has an FCI of 52% and is classified as critical. The school will be replaced utilizing the current elementary school prototype design with an SRC of 705.

Valley Elementary School is a 54-year-old building, with no renovations in the last 47 years. It also has an FCI of 52% and is also classified as critical. Valley Elementary School will also be replaced utilizing the current elementary school prototype design with an SRC of 705.

The request for local planning approval and BTL funding for these final projects of our FY2023 capital program will be submitted within the next 30 days. We respectfully request that the Commission grant local planning approval and approve BTL funding for both the Green Valley and Valley Elementary School replacement projects when they are before you for consideration.

We have worked creatively to reduce school construction costs using prototype designs, value engineering and partnerships within our community. We have successfully utilized the CM-at Risk delivery method with the Brunswick Elementary School replacement project. We continue to work with our County Executive and Council to find creative ways to fund other school construction projects, such as the addition to Oakdale Middle School. The Oakdale Middle

School addition was funded with local funds only and utilized a modified design-build delivery method. Because of the success with the Oakdale Middle School project in reducing the typical cost of construction while completing the project in an efficient and timely manner, we will be seeking to fund the addition to Crestwood Middle School in a similar fashion.

We feel strongly that our ability to provide a proper academic and instructional program, as well as our students' ability to achieve high standards, depends on adequate school facilities. We ask that this Commission continue to be an active partner with FCPS and Frederick County government and fully approve our FY2023 school construction requests.

I would now like to introduce the Frederick County Executive, Jan Gardner, to provide testimony.

On behalf of Charles County Public Schools, and those that represent us in the local

and state government, we thank the IAC, MSDE, MDP, DGS and all State support staff

for their continued advice, assistance and sensitivity to our growing needs for capacity

and renovations to aging facilities.

Everyone in Charles County is quite pleased with the great communication always

present between all of your staff and our Planning & Construction Office.

Charles County is continuing to renovate our existing buildings in an effort to bring them

up to 21st century learning standards. Charles County Public Schools has two major

renovation projects, a new school and a limited renovation project that address existing

open space classroom areas and create enclosed classrooms, in construction and design.

Charles County saw an increase in enrollment of 107 students in 2021 and we expect that

trend to continue. Charles County saw a decrease in enrollment last year due to the

pandemic and a small rebound this year but expect to continue to rebound next year.

Charles County has presented a CIP that offers balance between renovations of existing

buildings, necessary systemic projects to prolong the life of buildings, and new schools

to address the demands that come from a growth county.

T.C. Martin Elementary School – Modernization/Addition:

The school was built in 1967, has not been renovated, and the major building systems have exceeded their normal life. The school received a Full Day Kindergarten addition in 2009. State Planning was approved in FY 2020. The project will modernize the school to meet the needs of 21st century learning. An addition will increase the State Rated Capacity from 450 to 656.

The appeal is for construction funding in the amount of \$7,627,450.00.

CURRENT STATUS:

Local planning and design funds were approved in FY 2021. Local construction funds are scheduled for FY 2023. The schematic design (SD) was submitted to IAC on October 14, 2021 and the design development (DD) documents were submitted to DGS on December 6, 2021. T.C. Martin ES will be moving into our swing space, which will be vacated at the end of this school year, to allow for a timely modernization of the existing building.

J.C. Parks Elementary School – Full Day Kindergarten Addition:

The school was built in 1967 and renovated in 1997. This school received temporary classroom space to accommodate the additional student needs for a full-day kindergarten in 2008. This addition will restore much needed permanent classrooms as the school is currently utilizing 3 portable classrooms. The current Kindergarten enrollment is 91 students and the full day Pre-Kindergarten enrollment is 38 FTE students, which have been impacted by the pandemic. As The Blueprint for Maryland's Future implements Full-Day Pre-Kindergarten additional spaces will be needed to support early childhood learning.

The appeal is for planning and construction funding in the amount of \$2,125,000.00.

CURRENT STATUS:

Local planning and design funds were approved in FY2021. CCPS has recently completed the solicitation process for architects for small projects and CCPS anticipates awarding contracts in January 2022. The design will begin in February 2022. Local construction funds are scheduled for FY 2023. State construction funds are requested in FY 2023.

Walter J. Mitchell Elementary School – Full Day Kindergarten Addition:

The school was built in 1965. This school received temporary classroom space to accommodate the additional student needs for a full-day kindergarten in 2008. This addition will restore much needed permanent classrooms as the school is currently utilizing 3 portable classrooms. The current Kindergarten enrollment is 83 students and the full day Pre-Kindergarten enrollment is 42 FTE students, which have been impacted by the pandemic. As The Blueprint for Maryland's Future implements Full-Day Pre-Kindergarten additional spaces will be needed to support early childhood learning.

The appeal is for planning and construction funding in the amount of \$3,517,000.00.

CURRENT STATUS:

Local planning funds were approved for a study in FY 2020 and local design funds were approved in FY2021. The study was completed in May of 2020. CCPS has recently completed the solicitation process for architects for small projects and CCPS anticipates awarding contracts in January 2022. The design will begin in February 2022. Local construction funds are scheduled for FY 2023. State construction funds are requested in FY 2023.

Middle School #9 – Planning:

The need is for additional school capacity in the St. Charles development area of Waldorf.

Continued development in the County's development district and the Town of La Plata

will cause enrollment at the middle school level to exceed the capacity of the existing

schools in that area. MS #9 site is being negotiated with the developer of St. Charles as

part of their school site donations mandated in Docket 90. The school is proposed with a

State Rated Capacity of 975 students and will serve a population that includes students

with special needs, students with low English proficiency, and children eligible to

participate in the free and reduced meals program.

The appeal is for planning approval.

The Board of Education of Carroll County appreciates the staff's 75% recommendation for \$4,537,875 of funding for the Carroll County Career & Technology Center (CCCTC) project. The Board of Education of Carroll County also appreciates the staff projections for an additional \$2,527,559 of additional funds to bring the total amount of FY23 funding for the CCCTC project to \$7,067,434. However, this amount of funding will put the CCCTC project dangerously close to running out of construction funding in FY23. Based on the current draw schedule, this amount of money from the State will leave the project with a little over \$500,000 remaining at the end of FY23. This amount of FY23 funding will require the project to receive the remaining \$13,178,794 in State funding in FY24 or the project will run out of funding. The Board of Education of Carroll County understands that these recommendations are based on an historically low amount of \$208 million for the School Construction Capital Budget. However, the Board requests that you consider increasing the funding for this project to ensure this important project remains on track.
